PUBLIC QUESTION TIME

Mr and Mrs Fenton from Carnaby attended the meeting regarding letters they have received about waste water escaping from the footpath outside 49 Moor Lane, Carnaby. They raised concerns about the contents of the letter from ERYC and queried when the dye testing was to take place as the deadline had now been reached. They also raised concerns about the legalities of ERYC charging householders for the inspection of their properties to find out which property was non-compliant to regulations. Clerk will email ERYC regarding this matter and will report the findings back to the PC and Mr and Mrs Fenton.

Rev'd Trowsdale attended the meeting, introducing himself as the new curate for Carnaby. The Church will be opened every day. Harvest Festival will be on Sunday, 20th September at 4.00pm. Clerk will put a notice on the notice board to inform everyone. There will also be another historical day in October. Rev'd Trowsdale has requested if there can be a sign in the village pointing the way to the 12th Century Church – he was advised to speak to Dave England at ERYC regarding this matter. A regular newsletter will be published approximately three times a year. Rev'd Trowsdale also enquired about outside lighting for the church – he was advised to speak to Dave England, ERYC.

The information printed in the Free Press and ERYC was obtained by the reporter from the ERYC meeting minutes (Standards Committee Meeting) which discussed an allegation made by Mr Pease against Cllr Kitching. Therefore Mr Pease himself has placed the information into the public domain.

9. LITTER/FLY TIPPING

There has been an increase in the amount of litter discarded in the village. Most of the litter is from fast food outlets, such as MacDonaldis, empty cans of alcohol, cigarette packets and drinks bottles. The Clerk has contacted MacDonaldis who will carry out a litter pick around the village in October. Worst affected areas are Church Lane, Main Street, Moor Lane near the railway crossing and Sticks Lane.

12: CLERKS REPORT:

1. Grants available from NALC to help PC's fund a website with regards to the Transparency Code. Parish Councils are now expected to have a website, publishing copies of agendas, minutes and finances.

2. Projector – Cllr Langham has purchased a projector for the PC as planning application will soon be obtained via the web only at a cost of £30. Cllr Langham has looked into purchasing a computer as well. ERYC have a range of second-hand laptops for approximately £150 but they only have a 3 month warranty. Curry's sell new notebooks/laptops for under £200. The Councillors agreed that a maximum spend of £300 could be spend on a new laptop.

3. ERYC are holding meetings to inform PC's about the Public Transport system available in each area, this includes rail, buses, taxis and voluntary car schemes. There was no interest to attend this meeting.

4. Complaint received from Adrian Clark in Haisthorpe regarding the road surface down Lowfield Lane. The Village Task Force have recently been in the Parish and it has been noticed that this road is in disrepair. Clerk will contact ERYC as to when work will be carried out.
5. BayWa have requested another meeting for the 7th October. Some Councillors present have agreed to attend. Clerk will inform BayWa.
6. Green Open Homes events – ERYC are looking for households who have installed green energy systems in their homes are willing to open up their homes for residents who are interested in implementing a similar system in their own homes. 7. Village Task Force have visited the Parish and have provided the PC with a schedule of issues outside the remit of the Taskforce – Clerk will contact ERYC as to when these tasks will be carried out. Hedges and road verges have been trimmed by the Task Force.
8. PCSO Milner of Humberside Police has produced a Parish/Town News Release. This reports contains a brief outline of crimes that have been carried out in the area. This was circulated to everyone at the meeting.
9. Donation – W C Watts have kindly donated concrete for the refurbishing the Pound area. Clerk will write a thank you letter in response to this kind offer.
10. Clerk to contact transport company Eddie Stobart advising them that lorries should be using Brid Bay Road to get to the Industrial Estate as the entrance to Moor Lane from the village is a dead end.
11. Manhole covers/drains near Carnaby House are overflowing/bubbling with water during heavy rains – clerk to contact ERYC.
12. A complaint has been received about speeding traffic going up Temple Lane, there is no footpath and the hedges are overgrown. Residents are asking for this to be one way system. Walkers are at risk of being knocked down by speeding cars – Clerk to contact Dave England, ERYC.
13. CAM – Cllr Kitching gave an update regards progress. No progress has been made with regards to a site for the memorial. A company on the industrial estate have been approached but have not committed to anything in writing as yet.
