- We have received a thank you letter from St John the Baptist church committee for maintaining the grounds of the Church.
- ERYC have informed parishes that we can now order supplies via ERYC supply line. Clerk will check this out.
- Cllr Daniels has purchased a filing cabinet and was re-imbursed £10 for a second hand filing cabinet. The current cabinet is not fully functioning. Documentation will be moved into the new cabinet. Documentation will be checked and where relevant some old documents will be destroyed.
- Cameras Cllr Daniels is looking at purchasing cameras to capture evidence of fly tipping and fly tippers.
- Community Pay Back Team several months ago a meeting with ERYC and the PC was held to look at the possibility of using the Community Pay Back Team to carry out tasks, such as litter picking in the Parish but as there are no facilities for them to use toilet facilities we were unable to use them. Cllr Burton has suggested that the PC obtain funding for a caravan to act as a welfare unit. Clerk will enquire as to whether ERYC have a welfare unit that we could hire, will also enquire as to whether the Community Pay Back Team is still looking for work in Parishes before applying for funding.
