- 1. Cllr Taylor raised concerns that pavement on Moor Lane, Carnaby is blocked by the overgrown verge— Clerk to report to relevant ERYC department
- Cllr Langham & Cllr Clark raised concerns that 2 street lights in the parish are being blocked by trees, (1st located between 39 & 41 Moor Lane, Carnaby & 2nd at 13 Lowfield Lane, Haisthorpe) – Clerk to report to relevant ERYC department
- 3. Pedestrian Crossing/Island on Main Street, Carnaby Cllr Howard has received a reply to our request from ERYC Traffic Management and unfortunately after the site visit our request doesn't meet the guidelines, footfall is low and due to locations of existing verges, barriers, entrances and utility apparatus, it would be difficult to site a crossing at an appropriate location that complies with the design guidance Cllr Taylor has requested we ask for a copy of the design guidance to further understand this decision Clerk to contact the relevant ERYC department to request this
- 4. Village Road, Wilsthorpe Cllr Howard understands the road is council owned but not adopted. We are also still waiting to hear back from the ERYC Land Terriers/Village Taskforce regarding maintenance responsibility – Clerk to report & update the relevant ERYC department.
- 5. Various potholes on Church Lane, Carnaby are getting worse Clerk to report to relevant ERYC department
- 6. Church fundraising appeal the parish council received an update from the church warden, it was agreed the parish council would help with advertising the appeal on our website and also with the distribution of letters to the residents in the parish
- 7. Asian Hornet Poster Cllr Taylor was given the poster from a resident who asked if it could be displayed on our noticeboards Clerk to copy, then display on both Carnaby & Haisthorpe's noticeboards
- 8. The broken glass in the Carnaby noticeboard has been replaced & repaired
- 9. A resident of the parish has raised concerns to Cllr Kitching about the removal of trees on Kingsgate near the new developments, and whether they are to be replaced Clerk to look at the planning application and investigate with ERYC planning department.
